Ungraded (Raw) Card Consignment Terms and Conditions

As part of making a submission to 4 Sharp Corners LLC, customers agree to the following Terms and Conditions. By completing your submission, you agree to abide by this Agreement and acknowledge that 4 Sharp Corners LLC is entitled to rely upon and benefit from these terms. All terms and conditions are subject to change.

1. Amendments to Terms: 4 Sharp Corners LLC reserves the right to modify, update, or change these Terms and Conditions at any time. Continued use of our consignment services following any such changes constitutes your acceptance of the updated Agreement. .

2. Submission Standards: All items must be in sellable condition upon receipt, meaning they are free from scratches, residues, scuffs, stickers, abnormal amounts of wear, or any other signs of damage. Return shipping and insurance costs incurred due to items being: (1) in a condition that deviates from accepted standards or (2) damaged due to insufficient packaging will be at the expense of the owner. To avoid any potential issues, please ensure that all items are securely and durably packaged to maintain their condition throughout transit. If you are unclear if your item(s) meet these standards, please contact us before shipping and we will be happy to assist you.

3. Packaging Requirements: To ensure safe transit and efficient processing, all cards must be submitted in proper protective sleeves/holders. All cards should be placed in a penny sleeve with a semi-rigid holder. **A fee of \$1.00 per card** will be assessed for any items submitted improperly or requiring additional preparation by our team.

4. Right to Refuse/Decline: 4 Sharp Corners LLC reserves the right, at our sole discretion, to refuse any item showing evidence of tampering, trimming, alteration, or questionable authenticity. Furthermore, we reserve the right to decline any submission or refuse to list specific items that do not meet our quality or value thresholds (e.g., low-value common cards like 1990 Donruss). Items rejected for these reasons will be returned at the consignor's expense.

5. Liability: 4 Sharp Corners LLC will exercise reasonable care in handling items submitted for consignment. However, if 4 Sharp Corners LLC determines that customer's item was lost or damaged while in 4 Sharp Corners LLC's possession, customer will be compensated based upon the fair market value of the item as determined by 4 Sharp Corners LLC, which may include filing a claim with our insurance carrier. The declared value the consignor provides with this submission is for estimating the insurance coverage only, and the fair market value of the item may be less than the declared value.

6. Third-Party Submissions: If submitting on behalf of a third party, the customer represents and warrants that the third party has agreed to this Agreement and has signed a duplicate copy. The customer agrees to provide that signed copy to 4 Sharp Corners LLC upon request.

7. Auction Operations: All consignment items will be listed on our eBay account dedicated to ungraded inventory: 4_sharp_corners_raw. Any item that receives one or more bids but remains unpaid by the winning bidder will be relisted in our next auction.

8. Fee Structure: Current rates for raw card consignment can be found on our website or in our consignment portal.

9. Unsold Items: Any raw card that completes its auction with zero bids will incur **a \$1.00 per item processing fee**. Additionally, all raw items that fail to receive a bid will automatically become the sole property of 4 Sharp Corners LLC.
